RESOLUTION FOR THE TOWNSHIP TO SET the July 1, 2021 through June 30, 2026 Flat Rate, Ready to Serve, and Commodity Charge Residential and Commercial Sewer Rates as presented by customer type and usage/volume below.

WHEREAS, The Charter Township of Emmett contracts with the City of Battle Creek Waste Water Treatment Plant to service the Charter Township of Emmett with sewer service, and,

WHEREAS, the City of Battle Creek is intending to charge the Charter Township of Emmett higher rates for said service effective July 1, 2021 and through June 30, 2026,

BE IT HEREBY RESOLVED that the Board, Charter Township of Emmett, does assign the following flat rate, ready to serve and commodity charge sewer rates for all residential and commercial customers by type and usage/volume, effective July 1, 2021 through June 30, 2026:




