Administrative compliance Reminders

To ensure compliance with local regulations and maintain smooth operations, please review the following administrative reminders:

1. **OUTDOOR GATHERING PERMITS:** All Outdoor Gathering Permit applications must be submitted at least **60 days in advance** of any scheduled public or promotional event hosted at your marijuana establishment. Additionally, if your event included temporary vendors, Peddler Permits must be secured **48 hours prior** to the event.
2. **NOTIFICATION OF CHANGES:** Any modifications to the establishment's operations- this includes staffing changes, management transitions, or alterations to the physical premises- must be reported directly to the Marijuana Administrator (myself) **immediately upon implementation**. This ensures records remain up to date and regulatory compliance is maintained.
3. **DUMPSTER AND WASTE MANAGEMENT REQUIREMENTS**
 - a. All dumpsters must be housed in a fully enclosed structure with doors that remain shut and locked at all times when not in use.
 - b. No waste or debris is to be placed in front of, around, or behind the dumpster enclosure.
 - c. The enclosure area must be well-maintained, clean, and free of violations that could compromise sanitation or security.
